PLANS FOR THE MOTH ERADICATION PROGRAM INCLUDE:

- Chemical filled diffusers called "twist ties" on trees in our neighborhoods and backyards.
- Ground pesticide sprays from trucks in our neighborhoods or by backpack sprayers in our yards.
- Pesticide filled plastic flakes sprayed from airplanes over agricultural and "forested areas" (Mt. Tam?).
- Plastic pesticide filled flakes, placed in a sticky adhesive and applied to shrubs in public and private yards.
- Sticky goo with permethrin, splattered on telephone poles and trees. Permethrin is a carcinogen, toxic to cats, bees and people.
- Mass release of millions of dyed, irradiated sterile moths and parasitic wasps.
- Treatments are designed to create continuous chemical exposure to the chemicals they emit for 3 5 years.
